# JOINT **SIBLING DISCOUNT**

## **GENERAL**

- Firbank Grammar School and Brighton Grammar School offer a Sibling Concession to families with children at both or either schools.
- This concession is valued at 5% of the annual tuition fee charged by each school for each full fee paying student.
- The concession will not apply to students who are in receipt of any other fee concession (including internal sibling concession) or scholarship.
- The concession will not apply to Firbank ELC students.
- The concession will apply so long as at least one child is enrolled at each school and so long as the balance of fees payable are paid by the due dates, or in accordance with an agreed payment schedule.
- The Board of Firbank Grammar School and the Council of Brighton Grammar School reserve the right to withdraw or vary the value of this concession at any time.
- The concession is not retrospective. Families will retain the concession already offered for siblings enrolled within each school.

## **APPLICATION**

- Families who wish to benefit from this concession must apply to the Finance Department at [billing@firbank.vic.edu.au](mailto:billing@firbank.vic.edu.au) at Firbank Grammar School and/or Brighton Grammar School before 1 January of the year in which the benefit is sought. Late applications may be processed at the discretion of each School for families joining the school(s) after 1 January each year.
- This application must be on the prescribed form which is available from the Finance Department at each School. Application forms are also available online at [www.firbank.vic.edu.au](http://www.firbank.vic.edu.au) and [www.brightongrammar.vic.edu.au](http://www.brightongrammar.vic.edu.au).
- Should a student be withdrawn from either School, the concession will cease.
