BUSINESS TERMS AND CONDITIONS

Enrolment of a student at Firbank is subject to the School's Business Terms and Conditions published on our website.

ENROLMENT FEES

An application to gain entry to the School must be accompanied by payment of a non-refundable application fee of \$200. When a student receives a definite offer of enrolment, a non-refundable, non-transferable enrolment fee of \$2,000 is payable within 7 days (unless otherwise agreed).

TUITION FEES AND GOVERNMENT PAYROLL TAX RECOVERY SURCHARGE

Firbank's tuition fees include the costs of all compulsory excursions and the Alumni Life Membership fee for Year 12 students. A portion of the Victoria State Government Payroll Tax is recoverable from all students.

JOINT SIBLING DISCOUNT WITH BRIGHTON GRAMMAR SCHOOL (not applicable for ELC students)

Upon receipt of a written application, a 5% tuition fee concession is available to students who also have a brother enrolled at Brighton Grammar School and are not receiving other fee assistance (e.g. scholarship or sibling concession) from Firbank Grammar School. This concession is not retrospective and only applies if all fees are paid by the due dates above, or in accordance with an agreed payment schedule.

The School reserves the right to withdraw or vary the value of any concession at any time.

The School reserves the right to prohibit a student from participating in optional excursions and activities where there is an outstanding account.

NOTICE OF WITHDRAWAL FROM SCHOOL

With the exception of Year 6, written notice of withdrawal must be given to the Head of Campus by the end of the term prior to the child's last term at the School. One term's tuition fee will be charged if insufficient notice is given.

One full semester's (two term's) notice of withdrawal is required for Year 6 students not intending to progress to Year 7 at Firbank. NOTICE OF WITHDRAWAL FROM BOARDING HOUSE

One semester's (two term's) written notice of withdrawal to the Head of Campus is required to avoid being liable for a further semester's (two term's) boarding fees. Please refer to the Business Terms and Conditions on our website for full details.

BILLING AND PAYMENT METHODS

A yearly invoice will be issued and payment options are:

- A full year's fees in advance - a discount of 2% is offered on tuition and boarding fees if full payment of all fees is received by 28th November 2025.
- 4 equal instalments are due by 9th January 2026, 20th March 2026, 5th June 2026 and 28th August 2026.
- 10 equal instalments are due on 15th of each month between January and October 2026.

LATE FEES AND OVERDUE ACCOUNTS

Where any fees are not paid by the due date specified on the invoice, a late fee of 15%pa of the outstanding amount will be charged to the account.
